Notice is hereby given that the 41st Annual General Meeting (AGM) of Diamines and Chemicals Limited ("the Company") will be held at Registered office of the company situated at Plot No.13, PCC Area, P.O. Petrochemicals, Vadodara – 391 346, on Thursday, the 20th day of July, 2017 at 12:00 Noon, to transact Ordinary as well as Special businesses as set out in the notice of AGM dated 28th April, 2017. The said notice along with proxy form, Attendance slip, e-voting communication and Annual report together with Audited Financial statements have been dispatched to all the members, at their registered address by Courier and electronically to those members, who have their e-mail addresses registered with the Company / Depository Participant(s), on 16th June, 2017. The aforesaid notice along with, other documents are available on website of the company at www.dacl.co.in and also available on the website of Central Depository Service (India) Limited (CDSL) at www.evotingindia.co.in. The dispatch of notice of 41st AGM and Annual Report for the financial year 2016-17 has been completed on 24th June, 2017.

As per Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is providing remote e-voting facility to its members to cast their vote by electronic means on all Resolutions set out in the Notice of AGM i.e. from a place other than venue of AGM, through e-voting services provided by Central Depository Services (India) Limited ("CDSL") on all the resolutions set forth in the Notice of 41st AGM. Members holding shares either in physical form or in dematerialized form, as on cut-off date of 14th July, 2017, may cast their votes electronically on all the resolutions set forth in the Notice of 41st AGM. All the members are hereby informed that:

REMOTE E-VOTING:

- It may please be noted that business to be transacted at the AGM will also be transacted by electronic means through e-voting service provided by CDSL.
- Members are requested to refer Notes to notice Point No. 22 (Page No. 7) of the said notice of AGM dtd. 28th April, 2017, regarding process and manner of E-voting.
- The cut-off date for the determining the eligibility to vote by remote e-voting at the AGM is 14th July, 2017
- The remote e-voting shall commence on 16th July, 2017 (from 9:00 a.m. IST) and end on 19th July, 2017 (5:00 p.m. IST). During this period, members may cast their vote electronically. The e-voting module shall be disabled by CDSL thereafter and e-voting shall not be allowed beyond 5:00 p.m. IST on 19th July, 2017. The voting rights of members shall be in proportion to the equity shares held by them as on 14th July, 2017 ("Cut-off date"). Any person who is a member of the company on the Cut-off date is eligible to cast vote on all resolutions set forth in the Notice of AGM.
- The facility of voting through poll will be provided at the AGM. The Members attending the meeting and those who have not cast their vote earlier by e-voting shall be able to vote at the meeting.
- A member may participate in the AGM even after exercising his right to vote through remote e-voting but shall not be allowed to vote again in the meeting.

- A member who is entitled to attend and vote in the meeting is also entitled to appoint a proxy to attend and vote instead of himself and a proxy need not be a member. The instrument appointing proxy should, however, be deposited with Registered office of the Company not less than Forty Eight hours before the Commencement of the Meeting.
- Any person, who acquires shares of the Company and becomes member of the company after dispatch of the Notice of the AGM and holding shares as on the cut-off date i.e., July 14, 2017 may obtain login id and password by sending a request at helpdesk.evoting@cdslindia.com. However if a person is already registered with CDSL for e-voting then existing user id and password can be used for casting vote;
